

#### INDEMNITY FORM

- ACKNOWLEDGE that SIC reserves the right to refuse entry at any time and in the event that I am required to do so, I will do it promptly.
- UNDERTAKES to indemnify and keep safe SIC against any and all claims, writs, summons, proceedings, judgment, orders, decrees, damages, costs, losses and expenses of any nature whatsoever which may result as a consequence of any acts and/or omissions by the Participant from the usage of the track, services, facilities and/or activities (any cause or reason whatsoever arising out of it)
- AGREE to be solely responsible for all belongings, including any parts attached to my vehicle/transportation and also for those brought in by my group, members, families and/or friends. I shall not hold SIC responsible for any losses.
- AGREE that the Participant shall be solely responsible for any damages arising from bodily injury, death and/or claims for property damages or losses, which may arise directly or indirectly out of the usage of the track, services, facilities and/or activities by the Participant. The Participant shall defend and hold SIC harmless for any said damages.



#### RIDING GEAR


#### **COMPULSORY:**




# PIT ENTRANCE

# PIT LANE SPEED LIMIT







#### FLAGS DURING EVENT DAY



1. Red - Session Stopped. All participants back to the pit(s)



2. Green Flag - Session Starts / Track Clear



3. Yellow Waved ---- SLOW-DOWN!! Hazard on track/ gravel/ grass. Reduce speed, no overtaking.



- 4. Yellow & Red Stripes
  - Debris on track surface (oil / water/ parts / etc.)


# RED LIGHTS

#### **GENERAL RULES**



• Do not drive against the track flow (track & pit-lane).



 Umbrellas may be used only if they are securely tied to the railing along the pit signalling area.



 Do not stop and assist your friend(s) on the track. Leave it to the marshals.



 No crew(s) allowed in Service Road without permission by Track personnel.



 No children 12 years old and below are allowed at the PIT & PITWALL area. Children are to be supervised by an adult at all times.



 All damages of track facilities due to oil spillage, hitting the safety barriers, etc. will be charged accordingly.



 Smoking is allowed only at designated area.
